Application deadline is **June 1<sup>st</sup> 2018**. Submission received after this date will not be considered. A panel of judges will choose finalists and finalists will be notified by July 1<sup>st</sup> 2018. The top 10 chosen performers will perform on stage at the Sugar Grove Corn Boil festival location, Thursday July 26<sup>th</sup> starting at 6:00 p.m. The final competition will be held on the Corn Boil stage on July 28<sup>th</sup> 2018.

Awards – The Winner will receive a 1<sup>st</sup> place certificate, \$2000 prize, and will be performing on the main stage on July 28<sup>th</sup> 2018, prior to the main performer. The 2<sup>nd</sup> place runner up will receive a 2<sup>nd</sup> place certificate and \$500 prize.
